The Personally Approved Giving Plan

FEBCanada's invitation to partners to join the ministry's Personally Approved Giving Plan (PAGP), continues to be met with a positive response.

Each month, new inquiries are made by ministry partners – who regularly pray, and financially support FEBC International.

Here is how the transaction works: when you enroll in the PAGP, your monthly gift is automatically deposited to FEBCanada from your chequing account on the 20th of each month ... or debited from your credit card re: your choice of the 1st or 15th of the month, until you advise the ministry otherwise.


